1. Dorado is in into the business of e-commerce and direct sales and is responsible for the functioning of its website [www.khana-kamana.com](http://www.khana-kamana.com)
2. Franchisee is taking up the authorised sales Super Franchisee of Dorado, for the purpose of selling Franchisees & Products of Dorado marketing directly to the customers.
3. Super Franchisee will have to promote the ULTIMATE CUSTOMER LOYALTY PROGAMME which offers a unique concept to Dorado's customers to convert their expenses into income by Dorado under the website [www.khana-kamana.com](http://www.khana-kamana.com) & Partner with Dorado in sales and expansion of its businesses across the city of \_\_\_\_\_.
4. The Super Franchisee agrees to pay a sum of Rs.50,00,000/- as the Super Franchisee fee.
5. Dorado will give the Super Franchisee an Authority of selling 100 Sales Franchisees of [www.khana-kamana.com](http://www.khana-kamana.com) in your area.
6. Super Franchisee will sell the sales franchisee through its office and sales staff.
7. Dorado will be providing Vouchers worth Rs.50,000/- to Super Franchisee as Return Of Investment as each franchise sold in your area up to 100 franchise.
